

## *Workers news from Iran*

### **SHAHO'S FACTORY**

Workers of SHAHO'S FACTORY gathered in city of SANANDAJ to take exception to non-pay wages and other benefits on 5<sup>th</sup> of May 2005.

Employers of SHAHO'S FACTORY have not paid labour's wages since February 2005. Also they have fired 55 conventional workers out.

Managing director of this factory in the name of TAHERI suspend factory without any reasons for two months.

Notwithstanding the fact that regime's responsible(s) know about labour's problems, but they do not take necessary act.

Should say that at SHAHO'S FACTORY in last few years about four hundred workers worked, but now it has only 80 workers.

### **DEATH OF TWO WORKERS**

In conformity with received news from city of KERMANSHAH two brothers in the names of DELAVAR and ISSA lost their life by reason of falling in silo of MILADKOH'S coal mine.

Thus somebody else was wounded as the result of that event.

In the course of last month, 34 workers lost their life by different events in IRAN.

### **ARANJONOB'S WEAVER COMPANY**

Employers of ARANJONOB'S WEAVER COMPANY sent out 25 workers of this company.

Discharged labours were conventional workers.

A few months ago employers suspended the remembered above company under the pretext of deficit of raw materials too.

Work's rule of the ISLAMIC REPUBLIC OF IRAN has deprived conventional workers from all benefits among them unemployment insurance therefore IRANIAN employers can fire workers out simply.

## **AN ACTIVE OF WORKER MOVEMENT WAS ARRESTED BY MINISTRY OF SECURITY**

According to received news from JAMAL CHERAGHVISI'S SOCIETY on 5<sup>th</sup> of May 2005, three officers of the above-named ministry captured MR. SADEGH AMIRI at his workplace and nobody has any information about his predestination until now.

MR. SADEGH AMIRI is a member of committee of investigating for establishing labour's organizations.

## **CHAPARABAD'S DAM**

On the basis of published news from city of OSHNAVIEH (It is Located in western AZERBAIJAN), province workers of CHAPARABAD'S DAM in OSHNAVIEH have not received their delayed wages yet. Should say in western Azerbaijan, province all of the industrial centres are met crisis.

## **DORAFSHAN'S COMPANY**

In conformity with received news from city of GHAZVIN, employers of Draftsman's company have fired 30 employees out.

It is worthy of mention that many industrial centres are met crisis.

Furthermore about one thousand labours have been sent out in the past 3 months.

## **ABADAN'S PETROLEUM COMPANY**

On 21st May 2005 retired workers of Abadan's oil company Gathered at take exception to non-pay the retirement benefits in front Of governorship of ABADAN.

The retired labours asked for investigating to their problems but the regime responsible(s) have not taken any action for dissolving labour's problem.

## **KHORASAN'S PERMIT COMPANY**

On 21st May 2005 discharged workers of Khorasan's permit company gathered in front of work's department of Khorasan province.

Objector workers asked for returning to work. It is worthy of mention that numerousness of those labours have affected with skin and pulmonary illnesses, by reason of making use of injurious materials.

## **GYLAN PROVINCE**

According to published news from Gylan province, employers of Tondar's industries continue to send out formal labours of that company and then they recruit conventional workers. According to the work's rules of the regime, the conventional workers are deprived from all labour's rights in IRAN.
