### **Worker news from Iram**

#### **TEHRAN**

**8/9/06**

**Mr. MANSOUR OSANLOO, the leader of TEHRAN BUS SYNDICATE who had been arrested by government on 22 December 2005, was released with one hundred and fifty thousand resolution of security after seven months.**

**The workers' strike of TEHRAN and suburb bus's company (SHERKAT-E-VAHED) showed power of workers for establishment their independent formations and other claims. The workers' campaign of SHERKAT-E-VAHED also internal and external supports on the side of Iranian workers and unions in the world from that campaigns and struggle for releasing arrested workers persuaded the Islamic regime to retreat. The communist party of IRAN thanks the workers' movement activists and all of left and communist parties in outside for defending of Iranian workers' campaign.**

**8/12/06**

**More than three thousand conventional workers of IRAN KHODRO COMPANY stopped working because the managers have decreased workers' salaries.**

**8/12/06**

**Employers and responsible(s) of SHARIATI HOSPITAL do not pay conventional workers' benefits. According to sent news these workers have reported employer action to the regime organizations. Each of them only gets 150 dollars per months.**

**8/30/06**

**One hundred and fifty workers who are employees of SAKHT-E-NIRO want to gather in front of parliament in TEHRAN. In conformity with news when that company transferred to private portion its owners did not do to their undertakings alongside of workers' rights any more.**

#### **BOKAN**

**8/12/06**

**Hundred cab drivers stopped working because of shortage of gas in the city of BOKAN. After that governor and president of the city council went to place of strike and then they promised cab drivers to dissolve the matter.**

## **SHOSH**

**8/12/06**

**Many of factory workers with their families gathered in front of governor's office of SHOSH. They worked for DEZFOL SUGAR CUBE FACTORY.**

**These workers said that they had not got their salaries and benefits for three years. It is necessary to say that employers of this factory have suspended their factory since 2003.**

## **GHAZVIN**

**8/13/06**

**More than 150 workers gathered in front of ministry of power in TEHRAN. Objectors asked for payment 13 years of their benefits and executing the classification of employments plan. These workers work for GHAZVIN DEPARTMENT OF WATER. Also this department has five hundred retired workers who have not got their legal benefits yet.**

## **TABBAS**

**8/15/06**

**The regime responsible(s) of TABBAS announced that more than three hundred labors have been discharged in the above-mentioned city since May 2006. On the basis of received reports employers of FLORIN & HAMRAZ SAZAN companies are going to fire 800 workers out in October 2006.**

**It is necessary to say, thousand workers have been discharged in Iran since April 2006. There is no organization to take care of them.**

## **NAISHABOR**

**8/15/06**

**Employers of RADSAN COMPANY do not pay workers' salaries! Also the employers never give other benefits to their employees. Should say this company only pays 45 dollars to female workers and 60 dollars to male workers per months in recognition of 192 work hours!**

## **LORESTAN PROVINCE**

**8/15/06**

**Service companies related to ministry of hygiene discharged 90 workers in the above-named province. Discharged workers have between 5 to 10 years service. These workers have referred to the regime responsible(s) and they have asked for going back to work but nobody takes care of workers' requisition.**

## **KERMAN**

**8/17/2006**

More than two hundred drivers of RAHBAR COMPANY struck because of their salaries have been come down. These workers said that they would continue to their protest if the company did not take care of their problems.

## **RASHT**

**8/19/06**

IRAN ELECTRIC workers are going to TEHRAN because they are going to continue their protest in front of government departments there.

They are 450 workers who have been unemployed for three years and they have not gotten any salary for 36 months. These workers had protested in front of governor's office of GILAN province several times too.

## **LORESTAN**

**8/20/06**

Hundreds factory workers have not got any salary for five months in LORESTAN PROVINCE. These workers have referred to governor's office of this province and they have asked for investigating of their problems a few times but they have not received any answer from the regime responsible(s) yet. These labors work for LORESTAN glassworks.

## **SANANDAJ**

**8/26/06**

After 8 days, workers' strike of PARRIS COMPANY was met the regime crush. Liberty of statement and right of formation were workers' requests. In the course of that attack the regime forces hit the objector workers, their children and spouses. The communist party of Iran condemns this wildly attack also we want liberal people and workers of all countries to support workers campaign of PARRIS COMPANY.

## **KAMIARAN**

**8/30/06**

On the basis of sent news two teachers named SASAN BABAI and FARZAD KAMANGAR were arrested by the regime. The above-named persons are members of Kurdistan human rights organization. Must say, nobody knows about their condition
