### **SAGHEZ**

9/2/06

Bakery workers had a meeting on the subject of raising their salaries in SAGHEZ on 2<sup>nd</sup> of September 2006.

They had invited governor to participate in that meeting too. The meeting was begun at 6:00 pm. After a few workers talked about their claims, governor insulted workers!!!

At the same time Mr. MAHMOUD SALEHI took exception to governor's words and said, "no one can insult workers even the regime high officials." At the end, workers announced that they would strike if the regime and employers did not take care of their requests.

9/3/06

On the basis of received news from SAGHEZ, 250 cab's drivers stopped working at 8:00 AM, on 09.03.06, because of shortage of gas. They gathered in front of governor's office on 3<sup>rd</sup> of September. The gathering came to an end at 2:00 PM.

### **MARIWAN**

9/3/06

Workers of LAVIN COMPANY stopped working, because of non-payment wages. These workers have not got any salary for last three months. Protesters wanted employers to pay delayed salaries. The mentioned company produces tank of water also it transfers water to MARIWAN.

### **GHAZVIN**

9/4/06

More than 170 workers of NAZNAKH Co. gathered in front of ministry of industries on Monday morning, 4<sup>th</sup> of September 2006.

They had gathered in front of parliament on 3<sup>rd</sup> of September too. These workers work for NAZNAKH COMPANY. It is necessary to say that they have not got any salary for two years!

9/20/06

Workers of NAZNAKH COMPANY protested again on Tuesday 20<sup>th</sup> of September 2006. In the course of recent months these workers have protested in front of the regime organizations several times. The above-mentioned company was closed and its employees were unemployed 2 years ago.

9/22/06

Employers of two industrial unit announced that they were going to close these companies. GHAZVIN compressor Company and ALVAND bulb company will be shut down on 23<sup>rd</sup> of September 2006. These companies have 790 employees who will be unemployed shortly.

## **ESFAHAN**

9/5/06

BARESH COMPANY was closed and its workers were unemployed in ESFAHAN. Unemployed workers have reported employers to department of labor for two months but nobody has investigated to workers' complaint.

9/16/06

Workers of RAHIMZADEH weaving factory gathered in front of governor's office of ESFAHAN. These workers asked for paying delayed wages. It is necessary to say that three hundred workers of this company have not received their salaries since last year.

9/6/06

Employers of KANAF weaving company are going to close their factory and discharge their employees. Also these employers had discharged 550 workers in the course of past years too.

## **SANANDAJ**

9/9/06

Discharged workers of Kurdistan weaving company are going to protest in front of governor's office on 11<sup>th</sup> of September 2006.

In the course of past three years employers of this company have fired 450 workers out without any reason! It is necessary to say that in the middle of occupying workers of this company about 180 workers have been involved in pulmonary illness and cancer. Also 11 workers have lost an organ of their bodies and 3 workers have lost their life as the result of event at their work-place.

## **BOKAN**

9/10/06

Workers of KHATAMOLANBIA weaving company have not gotten their salaries for three months. At present, these workers have asked for investigating to their problems.

9/21/06

A young worker called KAMAL lost his life as the result of falling inside of brick-kiln. The above-named person worked for ETEMAD brickworks.

## **KASHAN**

9/12/06

Hundreds factory workers closed road of KASHAN & GHOM, because they have not gotten any salary for 4 months. After workers' act governor and responsible of department of labor promised workers to investigate workers' problems. These workers work for MAKHMAL & ABRISHAM weaving company.

## **SEM NAN**

9/13/06

Workers of SAMAND TILE factory stopped working to struck. Should say, these workers have protested with regard to non-payment salaries a few times, but employers do not pay attention.

## **GHAEMSHAHR**

9/13/06

One hundred twenty workers of HARIR paper-mill reported employers to department of labor. They also asked for paying delayed wages and going back to work. It is said, when this factory transferred to private portion four years ago, its new owners closed it then they discharged all employees.

## **BABOLSAR**

9/13/06

Three hundred unemployed workers with their families protested in front of ALBORZ carpet's company. Protesters also were going to go to governor's office but the regime disciplinary forces made an attack to workers then arrested a few of them.

This company has been closed since 2005.

## **TEHRAN**

9/20/06

More than 300 workers protested in front of KAVEH FACTORY then they asked for investigating to their difficulties. Protester said that employers wanted to close this factory.

## **PAKDASHT**

9/21/06

Employers of brickworks have closed their factories in the city of PAKDASHT. From beginning of this year more than 40 brickworks have been shut down and thousands workers have been unemployed until now. 70 brickworks were in production in PAKDASHT but at present there are only 25 brickworks in activities.

## **KOHKILUYEH & BOIRAHMAD**

9/22/06

More than two hundred workers of KOSAR DAM have not got their salaries for six months! These workers want to go on strike.

## **BOSHEHR**

9/23/06

Employers of DASHTESTAN COMPANY are going to closed one shift and they also are going to discharge some of workers. At present about one hundred workers work for this company.

## **SAVEH**

9/24/06

Employer of POMER COMPANY has fired 18 workers out in the course of past days. Discharged workers have reported employer to department of labor and they have asked for going back to work.

## **KERMANSHAH**

9/26/06

150 workers stopped working because they have not got any wages for 3 months. Protester workers asked for paying delayed wages. These labors work for PARS FAN TADBIR COMPANY.

## **GARMSAR**

9/30/06

Workers of SAIPA FACTORY struck on Saturday 30<sup>th</sup> of September 2006. Employers of this company have not pay worker's salaries for 4 months! It is necessary to say that these workers have protested few times but nobody pays attention to their requests.
