

Worker news from Iran

TEHRAN

10/01/06

Employers of AKSDANEH COMPANY have not paid workers' salaries since March 2006. They also have discharged 20 conventional workers too. It is said that these workers have gone on strike for two times.

10/01/06

Workers of BAFKAR COMPANY protested in front of this company on Sunday 1st of October, 2006. This company has been sold to a person whom wants to close it and discharge all workers.

10/05/06

Representatives of Iran's teacher gathered in front of ministry of education in TEHRAN. They asked for investigating to teachers claims.

10/29/06

Hundreds factory workers gathered in front of parliament on Sunday 29th of October, 2006. Those workers protested with regard to the Islamic regime work's law.

TABRIZ

10/01/06

Formal and conventional workers of ARAS CHINAWARE FACTORY gathered in front of department of labor in TABRIZ. These workers have not got any salary for 8 months. It is necessary to say that employers of this factory are going to close it.

GHAZVIN

10/02/06

330 factory workers protested in front of governor's office in the city of GHAZVIN. These workers worked for PARS carpet's company which has been closed since March 2006.

KARON PAPER-MILL

10/03/06

More than one hundred workers of KARON PAPER-MILL have not got any salary for 8 months! These workers announced that they would protest if employers did not pay salaries and other workers' benefits.

YAZD

10/04/06

Workers of DERAKHSHAN weaving company have gotten their wages for two times since February 2006.

Employers do not want to pay workers' salaries any more without any reason. At present, these labors are going to protest in front of the regime organizations in TEHRAN.

10/16/06

Workers of GERDBAF COMPANY protested in front of governor's office of YAZD province. Objected workers requested employers to pay their delayed salaries. That gathering came to an end after 3 hours.

FASA

10/05/06

All of workers of FASA SUGAR CUBE FACTORY asked for taking care of their problems, paying delayed wages, stopping transfer some parts of factory to private section, changing managers and removing discrimination between workers.

GACHSARAN

10/06/06

Employers of GACHSARAN oil's company have not paid workers' salaries for 6 months.

In spite of workers' protests, nobody pays attention to rights of workers. This company has 2200 employees.

PAKDASHT

10/08/06

More than 2 hundred workers of SAZMAYEH BRICKWORKS walked from their work-place to governor's office on 5th October, 2006. Workers of this company have not gotten any wages for 20 months!

HORMOZGAN

10/09/06

HORMOZ NAKH COMPANY was closed and 112 labors were discharged. According to sent news, employers want to transfer machinery of this company to **TABRIZ**.

FARS PROVINCE

10/09/06

PADANA COMPANY was closed and its conventional employees were unemployed. In conformity with the Islamic regime work's rules un-formal workers have no rights.

SARI

10/10/06

Workers of **RAJAI COMPANY** gathered in front of governor's office in the city of **SARI** on 10th Oct., 2006. When the above-named company transferred to private portion seven years ago, new employers closed the factory and fired out all workers.

MASHHAD

10/10/06

Workers of **MASHHAD ZOBRECORD COMPANY** gathered in front of department of labor on 10th October, 2006. Protested workers asked for going back to work. The above-named company was shut down last month.

SANANDAJ

10/13/06

Workers of department of road construction stopped working by reason of non-payment wages. At the time of that strike, employer promised labor to investigate workers' problems.

10/20/06

According to sent news, workers of **SANANDAJ** handmade arts have not got any salary for seven months! These workers have informed employer that they are going to protest in front of governor's office as soon as possible.

10/28/06

Employers of PARRIS COMPANY are continuing to discharge workers. On the basis of recent news two workers named KHABAT MORADI and FARHAD REZAI were discharged a few days ago.

10/29/06

Workers of SHAHO FACTORY struck on 29th October, 2006. These workers protested because of un-payment salaries and other benefits. At the end, they imposed their claims to employers and that strike came to an end with success.

GILAN

10/15/06

ZOCAL COMPANY was closed and its workers were unemployed. Employers have transferred machinery of this company to the city of KARAJ. They say, " If employees want to keep their job they must go to the new work-place of company in KARAJ."

ISLAM ABAD

10/15/06

Four workers who worked for ISLAM ABAD sugar cube factory lost their life as the result of an event and 16 more workers were wounded.

SAGHEZ

10/16/06

After MAHMOUD SALEHI received a summons, he went to SAGHEZ revolutionary court on Monday 16 Oct., 2006. Mr. Salehi is one of the SAGHEZ labor leaders who had been arrested in 2004. Also JALAL HOSSAINI went to court on Wednesday 18 Oct., 2006.

Mr. HOSSAINI is on of the workers' movement activists in Iran and Kurdistan too.

SHAHRIAR

10/17/06

Employers of PARANDEH PARVAZ COMPANY discharged 30 formal workers under the pretext of financial problems. Also they have not paid workers' wages for four months. Discharged workers said that employers had recruited conventional workers instead of formal workers.

WESTERN AZARBAYEJAN PROVINCE

10/21/06

From beginning of this year, until now, 150 workers who worked for macaroni factories have been discharged in AZARBAYEJAN. Employers say that the reason of discharges is financial problems!

OROMYEH

10/23/06

81 conventional workers who worked for SHAHIN TAVFIGH COMPANY were fired out. Also these labors had not got any wages for 4 months!

KERMAN

10/29/06

Workers of KERMAN municipality with their families gathered in front of mayor's office on 10/29/2006. These workers protested, because of transferring the cleanliness section of municipality to private companies.
