12/06/06

12/18/06

12/20/06

Workers of IRAN SADRA brought to an end their strike and they came back to work on 20th of December.

12/06/06

Seventy factory workers who worked for FADAK COMPANY have been discharged. Although department of labor has voted to going back workers to work, but employers do not take care.

GHAZVIN

12/06/06

Ten formal workers have been fired out. These workers worked for ALBORZ DARO COMPANY. Discharged workers have reported employers to department of labor.

12/10/06

After workers of PARS COMPANY prevented from taking machinery of this company, authority arrested 9 of them.

The above-mentioned company has been closed and its employees have been unemployed since 2005.

12/10/06

Protester workers of POSHINEH BAFT closed road of GHAZVIN to the industrial city of ALBORZ then they asked for paying wages and other benefits. When POSHINEH BAFT was transferred to private section last year, it has met crisis.

12/17/06

Employers of KELACH CHODANI COMPANY are going to close their company. This company has 71 workers.

HAMADAN

12/06/06

A few unemployed workers gathered in front of governor's office of HAMADAN province on 12th of September, 2006.

Those workers worked for EKBATAN weaving's company.

According to workers' statement, employers have closed the above-named factory without any reason!

TEHRAN

12/07/06

In conformity with sent news from the bus workers' union, MANSOUR OSANLOO who was arrested on 19th of November, 2006 is still locked up.

Mr. GHOLAMREZA GHOLAM HOSSAINI is still in jail.

12/09/06

GHOLAMREZA GHOLAM HOSSAINI, SEYYED DAVOUD RAZAVI and ABDOLREZA TARAASI activists from the bus workers' union who had been arrested in recent days were released from jail.

12/17/06

12/13/06

12/19/06

TAKESTAN

12/20/06

12/24/06

12/24/06
