

SANANDAJ

01/01/07

On Monday morning 1st of January about three hundred discharged workers who worked for Kurdistan weaving company protested in front of department of labor in the city of Sanandaj. According to sent news, one hundred of them agreed with retirement and other workers asked for returning to work.

01/02/07

14 workers were discharged by employers of SANANDAJ dairy farm. It is said that this factory has no any problem in the light of produce and sale.

01/02/07

Ten workers who worked for Kurdistan medical collage were discharged.

01/09/07

More than 380 discharged factory workers who worked for Kurdistan weaving, SHAHO and ALOMIN companies gathered in front of department of labor.

In the course of that protest representatives of those workers spoke with responsible of department of labor about protesters' claims. Paying loan, paying unemployment insurance and going back to work are workers' claims.

01/01/07

Employers of SIMINBAL COMPANY do not pay workers' salaries. According to sent news, 30 workers of this company have not gotten any wages for 5 months. These workers have asked for paying delayed salaries. It is necessary to say that employers have discharged 90 workers in the course of past months.

01/21/07

Formal workers of SINA COMPANY gathered in front of this company because of non-extending agreements of conventional workers. Those workers asked for going back discharged workers to work.

PADNA AND IRAN COMPANIES

01/02/07

The above-named factories were closed and four thousand workers were unemployed!

GILAN

01/05/07

28 factory workers have been discharged by employers of SIMIN BAFT Company under the pretext of decreasing of produce. It is said that workers have asked for going back to work.

DEZFOL

01/07/07

On the basis of sent news, more than four hundred unemployed workers with their families protested when the Iranian president was visiting the above-named city. These workers worked for DEZFOL SUGAR CUBE FACTORY. Protesters asked for paying their claims. In the course of that protest the regime forces attacked on workers.

ABADAN

01/07/07

More than two thousand conventional workers who are working for KHOZESTAN Oil Company protest in front of this company every day. Should say, employers are going to discharge these workers.

RAMSHIR COMPANYY

01/08/07

Two hundred workers of RAMSHIR COMPANYY went on strike because of nonpayment wages. Those workers have not gotten any salaries for five months. Protester workers want to continue their strike until they get delayed rights.

TEHRAN

01/09/07

Workers of Tehran NOSHAB FACTORY gathered in front of this factory. These workers have not received any salary in the past months. Protesters said that if employers did not take care of workers' claims they would continue their protest.

This company has been closed and its workers have been discharged since last months.

01/17/07

16 factory workers who work for BAFT AZADI COMPANY were discharged because they had protested as compared with delayed wages. Labors of this company have not received any salary for ten months.

GHAZVIN

01/10/07

150 factory workers protested in front of AHMADINEJAD'S OFFICE because of non-payment salaries. Workers said that they had protested in front of government office of GHAZVIN before. It is necessary to say that these workers work for POSHINEH BAFT FACTORY.

01/21/07

Workers of GHAZVIN NAZNAKH COMPANY stopped working and they asked for investigating their claims. It is said that new employer of this company does not pay workers' salaries.

01/22/07

Unemployed workers of ALBORZ FACTORY closed main road of GHAZVIN about 20 hours. This factory has been shut down since January 22nd, 2007.

It is necessary to explain that employers have not paid any salary to their employees for 5 months.

LORESTAN

01/14/06

Workers of LORESTAN REFRIGERATOR COMPANY gathered in front of main office of the above- mentioned company in Tehran. Employers have to pay 6,000 dollars to every one of them.

RAMSAR

01/15/07

Two workers named HOSSAIN PAYEHDARI and HOSSAIN MAZLUM lost their life as the result of an event at work-place. The above-named workers worked for municipality of RAMSAR.

SEM NAN

01/16/07

More than two hundred factory workers who work for PAKRIS COMPANY protested because of writ of attachment of this company on the side of judicial organization.

KURDISTAN SPINNING FACTORY

01/21/07

More than one hundred workers who work for Kurdistan spinning factory gathered in front of department of labor in SANANDAJ.

Protesters want responsible(s) to take care of their problems. Workers said that if responsible(s) did not dissolve workers' difficulties, they would strike on February 5th, 2007.

SAGHEZ

01/22/07

Employers of contract companies related to municipality of SAGHEZ have not paid workers' salary for four months. The employers say, "the above-named municipality does not allocate any credit for paying wages to workers.

01/26/07

The court of Kurdistan province is going to try (judicially) MAHMOUD SALEHI and JALAL HOSSAINI again on February 9th, 2007.

ABIK

01/24/07

When more than two hundred factory workers who work for MOJDEH VASL SHIRAZ factory were protesting the regime forces attacked on them. These workers have not gotten any wages for four months.

OSHNAVIEH

01/26/07

On the basis of received news from OSHNAVIEH, employers of SAFAR ABAD Dam Company have not paid any wages to their employees since six months ago. Workers of the above-named company have protested several times but employers don't pay attention to workers' claims.

MAZANDARAN PROVINCE

01/26/07

Workers of SARIT Company protested as compared with transferring this company to private section. Protesters said that they would continue this protest until they get their claim.
