

TABBAS

06/01/07

350 workers who work for PAMIKO Company, protested in front of labor's house in TABBAS. Employers of the above-mentioned company are going to fire all of their employees out in a few days.

GHAZVIN

06/02/07

Seventy female workers and twenty male workers who are working for EIMAN ZARIF Factory gathered in front of labor's house and they asked for taking care of their problems. These workers said that employer had refused paying other benefits to employees. According to received news, female workers only get 150 dollars and male workers get almost 200 dollars every month. We have to say that the line of poverty is 550 dollars in Iran!

06/14/07

250 conventional labors who work for PARS ZENICH Company, gathered in front of labor's house in GHAZVIN. According to workers' statements, employers don't pay wages to their employees on time.

06/15/07

The PARS'S employees protested in front of governor's office of GHAZVIN then they asked for paying delayed wages, investigating to their problems and going back to work. This company has been closed for months and workers' delayed salaries, have not been paid yet.

06/18/07

The workers of PARS Company protested in front of governor's office of GHAZVIN again. These workers have protested several times since last month.

KHOSESTAN PROVINCE

06/02/07

More than five hundred factory workers, who are employees of HAFT TAPEH Sugar-Cane Company, went on strike and they asked for paying delayed salaries. These workers have not gotten any wages for few months! Protested workers said they would continue to their strike in front of the Islamic regime organizations, if employers didn't investigate workers' difficulties. It is said that this strike was the biggest workers' protest in June.

06/13/07

The workers of HAFT TAPEH Sugar-Cane went on strike again and they also close minor road to capital of KHOZESTAN Province on June 13. These workers said that employers had promised to pay delayed salaries, but no action was taken from their side, until now.

06/16/07

The HAFT TAPEH workers have been striking for six days. On Saturday morning, first workers gathered at their workplace, then they began walking on streets around the factory.

Important news

06/03/07

- IRANSHAHR BAT BALOCH Factory was closed and all its workers were unemployed on June 1, 2007. This factory had eight hundred labors.
- More than 320 workers who worked for KERMAN Motor Factory were discharged on 2nd of June, 2007.
- Tens discharged workers of YAZD Steel-Works, have not gotten delayed wages yet.

ARDEBIL PROVINCE

06/03/07

More than sixty workers protested in front of governor's office of ARDEBIL Province and they asked for paying their claims. These workers, who are working for SABALAN Company, haven't received any wages for five months!

Workers said: "They will continue to their protests, if employers don't pay delayed wages."

06/06/07

Hundred workers who are working for ARTA Company, gathered in front of governor's office of ARDEBIL Province on June 6, 2007. According to received news these workers haven't got any wages for four months!

GHOM

06/03/07

More than three hundred workers of HAMID Company went on strike on 3rd of June, 2007. These workers are going to protest until they get their claims. It is said that employers haven't paid any salaries to employees for two months!

06/07/07

Five hundred labors who work for Tehran Blanket and Iran Cashmere companies went on strike then they asked for paying delayed claims. These companies have not paid any wages to workers for four months! Workers have announced that they would continue to their protests.

DEZFUL

06/03/07

Workers of a refinery in DEZFUL, stopped working and they asked for paying their claims. Protesters have not gotten any wages for seven months!

SHABESTAR

06/07/07

On the basis of sent news, in WAYEGAN'S area, the place where is close to the city of SHABESTAR, whole workers of brickworks, went on strike on June 07, 2007. These workers asked for increasing salaries. It is said that majority of them are from Kurdistan.

GHORVEH

06/08/07

A teacher's activist named ALI ZIAI was arrested by the Islamic regime security forces on charge of managing teachers' protested and taking action against national security. The above-named person had been arrested last year too.

TEHRAN

06/09/07

Mr. EBRAHIM MADADI, vice-president of the Workers' Syndicate of Tehran and Suburb Bus Company said that department of labor had issued discharge sentence of six workers in the names of DAVOD RAZAVI, MANSOUR HAYATGHAIBI, ABBAS NAZHAND KODAKI, SAEED TORABIAN, EBRAHIM MADADI and YAGHOB SALIMI.

06/13/07

On Wednesday 13th, more than five hundred employees of Social security protested in front of this organization in Tehran. Insider said: "The protesters had asked for investigating to their problems."

06/20/07

On Wednesday morning, June 20, 2007, hundreds retired workers who used to work for Iran Communications Company (phone) protested in front of ministry of connections in Tehran. Retired workers asked for increasing salaries and other benefits.

SANANDAJ

06/08/07

A construction worker named ESMAAIL VAISIAN lost his life as the result of wall fall in and other worker were injured severely.

06/09/07

MOHAMMAD SHARIF says, "MAHMOUD SALEHI is going to go on hunger strike." As every one knows, SALEHI has renal problem. He has requested

the revolution court to give him sick leave, but unfortunately he hasn't received any answer from the regime yet.

06/17/07

A few more workers of Kurdistan spinning factory, were fired and transferred on June 17, 2007. Five hundred workers of this company have been discharged since 2004.

TORBAT HAIDARYEH

06/11/07

Workers of a few brickworks in DOLAT ABAD'S area went on strike because of non-payment delayed wages.

Those workers hadn't gotten any salaries for months! Should say, protesters are going to continue to their strike.

HAMADAN

06/13/07

85 conventional workers whom work for SINA Company protested in front of labor's house of HAMADAN Province. The SINA'S Employers have not paid any salaries and other benefits to workers for a few months!

SAQEZ

06/13/07

The SAQEZ revolution court has summoned five workers' activists in the names of KHALED BIKHANI, RAHIM HOSSAININ, ATA HOSSAINI, KAMEL HAKIMI and ANVAR HASSANZADEH because they had defended MAHMOUD SALEHI.

KAMIARAN

06/15/07

A construction worker named RAHIM MORADI lost his life when he was working. The above-named person has three children. It is said that another worker from SANANDAJ, who used to work in Iraq, lost his life as the result of an event at his work-place.

MASHHAD

06/18/07

Workers of PART SAZAN Company protested because employers had fired six workers a few days ago. Those workers asked for going back discharged workers to work.

OSLOYEH

06/18/07

1200 factory labors who work for RAMSHIR Company went on strike on June 18, 2007. These workers have not got any salary and other benefits for five months! It is necessary to say that they have protested against employers' act several times.

06/23/07

Fortunately, the RAMSHIR'S workers could get some of their claims. These workers had gone on strike because of unpaid salaries by employers on June 18, 2007.

MAZANDARAN Province

06/20/07

As the result of a coal- mine falling in two workers were killed on June 20, 2007. This coal-mine is located in the city of NOOR.

GHAEMSHAHR

06/21/07

Workers of GHAEMSHAHR Spinning Factory # 2, gathered in front of governor's office of the above-named city on June 21, 2007. Should say this factory has 430 employees who have not gotten any wages for five months! These workers may be unemployed because employer has transferred machinery of this factory to unknown place.

TABRIZ

06/22/07

A few discharged workers who worked for YAGHOT-E-SABZ Factory, protested in front of labor's house in TABRIZ. Employers have fired 41 workers under the pretext of financial problems. These workers asked for going back to work.
