

ESFAHAN

09/01/07

According to the Islamic regime court order, a school teacher named HAMID MAJIRI has been fired out and two more school teachers named EMADI and RAHMATI have been banished in the city of ESFAHAN.

ILAM

09/02/07

As the result of an explosion four municipality workers were killed and wounded when they were working.

TABRIZ

09/03/07

On 3rd of September, A construction worker was killed because of wall falling in. The construction workers have not any insurances, safety devices/clothes.

MALAYER

09/03/07

A twenty three-year-old worker named ALIREZA lost his life as the result of falling from top of a high building and no care about his death, because they have not insurances.

BANDAR TURKAMAN

09/03/07

A carwash worker lost his life while he was working at his workplace on September 3rd 2007.

SHIRAZ

09/03/07

As the result of an explosion three workers were killed and wounded on 5th September, 2007.

SANANDAJ

09/04/07

MAHMOUD SALEHI, well-known workers' activist, was transferred to the hospital again. Although Mr. SALEHI must be confined to bed in hospital, but the regime doesn't care about his critical body situations.

09/05/07

Responsible(s) of Kurdistan medical university have retired five members of masters of the university. Those five masters did not want to be retired.

09/16/07

Mr. SALEH NIKBAKHT, who is SHIS AMANI and SEDIGH KARIMI'S lawyer, has objected with regard to issued orders for his clients. He says, "The issued orders were communicated to me and I objected with regard to those orders." It is necessary to explain that the above-named persons have been sentenced to two years and six months imprisonment.

09/26/07

Twenty two workers of Kurdistan Spinning Factory were fired out by their employers on 1st September, 2007. Social security, governor's office, department of labor and the regime department of security have supported employers' action.

09/27/07

Discharged workers of Kurdistan Spinning Factory protested in front of this factory and they asked for going back to work. It is said that the regime forces have threaten these workers.

TEHRAN

09/04/07

A school teacher named MOHAMMADREZA REZAI GORGANI was trialed by the regime court in Tehran on 4th of September, 2007. This teacher has been accused of taking action against internal security.

09/07/07

Tens factory workers who have been fired out by the employers of VITANA Company, gathered in front of this company and then they asked for going back to work. This company has been shut down since last months. On the basis of received reports these workers have protested against this act a few times.

09/08/07

Mr. DAVOOD RAZAVI, workers' activist, was released on 8th September, 2007. RAZAVI had been captured with five more workers in front of OSANLOO'S house last month.

09/16/07

Many of school teachers gathered in front of Iranian president office in Tehran on September 16th. Those teachers wanted the Iranian government to take care of their requests.

MARVDASHT

09/06/07

AZMAYESH Factory workers have been striking since last month. More than 1400 labors were working at this factory, but employer of this Factory fired out one thousand of them and now this place has only four

hundred employees. It is said that discharged workers gather in front of former workplace every day.

KERMANSHAH

09/12/07

Four hundred workers of Kermanshah slaughter-house went on strike. According to sent news, new owner of this place is going to transfer it to other neighborhood and he wants to keep 30 workers.

09/23/07

The workers' strike of Kermanshah slaughter-house came to an end. On the basis of sent reports from Kermanshah, the employees of the Slaughter- house could impose their claims to their employer.

09/23/07

The Kermanshah water & dust company workers protested in front of their workplace and asked for paying delayed wages on 23rd September, 2007. These workers have not gotten any salary more than four months! It is said that they work 11 hours every day!!!

KHOZESTAN PROVINCE

09/13/07

On the basis of human rights activists report, five thousand workers who work for HAFT TAPEH Company went on strike again. Those workers asked for paying delayed wages. Those labors have protested several times, but the regime officials do not pay attention to workers' claims.

MASHHAD

09/15/07

The Islamic regime court has issued order of deducting legal salaries for 80 school teachers in the city of MASHHAD. Inconformities with this order one day teachers' wages and other benefits have been deducted.

KHORAM ABAD

09/16/07

On Friday morning September 14th, the regime forces made an attack on workers' and women's movement activists meeting in the above-mentioned city. In the course of that operation, twenty-five people were captured.

09/19/07

More than two hundred factory workers who are working for PARSILON Factory, protested in front of governor's office of LORESTAN Province on 18th September. These workers have not got any salary for six months! From four years ago the employers of PARSILON Factory have discharged hundreds workers until now.

BANEH

09/19/07

The Kurdistan education fired out a school teacher named LOGHMAN SEDAGHAT because of unobserving Islamic orders! The above-named person has nine years service in high schools of BANEH.

GHAZVIN

09/23/07

PARS FACTORY workers protested in front of the governor's office of this city again and then they asked for investigating their problems. More than seventy occupation workers and 126 retired workers of this factory haven't got any wages for one year. It is necessary to say that these labors have protested many times, but the regime officials don't take care of workers' claims.

GILAN PROVINCE

09/24/07

Workers of Pipe & Reinforced concrete productions company, stopped working on 24th September, 2007. Workers say, "according to employers' decision, five hectares of lands of this company will be sold to a university and two hectares will be sold to agriculture department." They also say, "This Company might be closed as the result of that decision. At present, more than four hundred workers have asked for non-transferring lands of this company.

ISLAMSHAHR

09/24/07

Because of unpaid wages, workers of TALEGHAN Wood Industries Company, gathered in front of their workplace on 24th of September. The TALEGHAN Company employers haven't paid workers' salaries for six months!

BOKAN

09/25/07

More than 30 workers who work for BOKAN KESHESH Company went on strike and asked for paying delayed wages. The BOKAN KESHESH employers have not paid any salary to their workers for four months. According to sent news the employers say, "They can't pay workers' salaries before December, 2007."

ALBORZ

09/27/07

Fifty discharged workers whom worked for PARS VASHER Company, reported their employers to governor's office of this city on 27th September, 2007.

These workers were fired out last week.
